

APPLICATION FOR THE CAROLYN STELL SCHOLARSHIP AWARD

Statement of Purpose: In order to promote greater access to the legal system and to better serve the legal needs of women in the community, the Mid-Michigan Region of the Women Lawyers Association has established the Carolyn Stell Scholarship Award. Its purpose is to provide financial assistance to women law students and to recognize the achievements of these students.

Award: The cash award will be payable directly to the winner at the **November 4, 2015** reception.

1. The award will be \$1,000.00, and
2. A certificate will be presented to the recipient of the award at the reception.

Eligibility: The woman must:

1. Be a resident of Ingham, Eaton or Clinton County;
2. Be enrolled in a law degree program (either full or part time) at an accredited law school and still be enrolled in a law degree program at the time of the award;
3. Possess a minimum cumulative grade point average of 2.5; and
4. Be able to attend the reception at **Crowne Plaza in Lansing, Michigan on November 4, 2015 at 5:30 p.m.**

Selection Criteria:

Selection shall be based on academic achievement, financial need and career objectives.

Application Process:

1. Complete an application and submit it by **October 26, 2015**;
2. Request a copy of her law school transcript be sent to the address listed below by **October 26, 2015**; and
3. Provide one (1) letter of recommendation from an independent party endorsing the applicant as a scholarship recipient by **October 26, 2015**.
